Group Experience Rating

▼ The Ohio Bureau of Workers' Compensation (BWC) permits "like" employers to pool their experiences, which results in an overall premium discount. While the BWC sets the maximum discount for each group year, Hunter Consulting is able to offer a number of discount levels in multiple industry groups; not to exceed the BWC preset maximum.

ENROLLMENT DEADLINE

Monday before Thanksgiving

Group Retrospective Rating

▼ Group Retrospective Rating is recommended for those employers who have significant claims in their experience.

It allows employers to pool together through a sponsoring organization and receive periodic refunds or assessments based on the performance of the group.

ENROLLMENT DEADLINE

Last Business Day in January

Eligibility Requirements for Both Programs

- ▼ Be a member of a certified sponsoring association (OCBA)
- ▼ Be a private, state-fund employer or a public employer taxing district
- ▼ Be current on any and all premiums or other monies owed to the BWC
- ▼ Not have cumulative lapses in excess of 40 days within the 12 months preceding the application deadline.

Note: For this to be a **valid** letter, the self-insured department for self-insured employers, or the employer services department for all other employers, must stamp it. Being temporary in nature, BWC will not record via computer or retain this authorization. Representative must possess a copy when requesting service relative to the authority granted therein.

This is to certify that Hunter Consulting Company (001220-80), including its agents or representatives identified to you by them, has been retained to review and perform studies on certain workers' compensation matters on our behalf.

The limited letter of authority provides access to the following types of information relating to our account:

1. Risk files;
2. Claim files;
3. Merit-rated or non-merit-rated experiences;
4. Other associated data.

This authorization does not include the authority to:

1. Review protest letters;
2. File protest letters;
3. File form *Application for Handicap Reimbursement (CHP-4)*;
4. *Notice of Appeal (IC-12)* or *Application for Permanent Partial Reconsideration (IC-88)*;
5. File self-insurance applications;
6. Represent the employer at hearings;
7. Pursue other similar actions on behalf of the employer.

I understand this authorization is limited and temporary in nature and will expire on _____ or automatically nine months from the date received by the employer services or self-insured departments, whichever is appropriate. In either case, the length of authorization will not exceed nine months.

Completion of the temporary authorization provides a third-party administrator (TPA) limited authority to view an employer's payroll and loss experience. By signing the AC-3, the employer grants permission to the BWC to release information to the employer's authorized representative(s). The form allows a TPA to view an employer's information regarding payroll, claims and experience modification.

Attention group rating prospects

- Employers may complete the AC-3 for as many TPAs or group-rating sponsors they feel are necessary to obtain quotes for a group-rating program.
- Group sponsors must notify all current group members if they will not accept them for the next group-rating year. The deadline for this notification is prior to the last business day in October for private employers and prior to the last business day in April for public employers.
- All potential group-rating prospects must have:
 - Active BWC coverage status as of the application deadline;
 - Active coverage from the application deadline through the group rating year;
 - No outstanding balances;
 - Operations similar in nature to the other members of their group.
- Any changes to a group member's policy will affect the group policy. Changes can result in either debits or credits to each of the members.

Note: For complete information on rules for group rating, see Rules 4123-17-61 through 4123-17-68 of the Ohio Administrative Code or your TPA. All group-rating applicants are subject to review by the BWC employer programs unit.

WHAT IS IT?

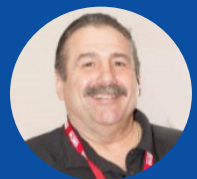

ORCA SUPPORTS COMMERCIAL ROOFING LICENSING

Ohio House Bill 88 *Sponsored by Representative Tom Patton*

The Ohio Roofing Contractors is excited to be supporting Representative Tom Patton from Ohio's 7th District in his initiative to enact Commercial Roofing Licensing. This effort has been a priority for ORCA since its inception and we are **CLOSER THAN EVER BEFORE!**

Last session this bill had an overwhelming bi-partisan vote in favor of passage in the Ohio House but ran out of time to be considered by the Senate. It's a new session and hearings are already underway to kick off consideration of HB88 and we are on a fast track for passage in this session! ***The bill is bi-partisan, has wide industry support and has been well received by the Commerce and Labor Committee!***

The bill establishes a license within the existing **Ohio Construction Industry Licensing Board** system, which currently licenses commercial Plumbing, HVAC, Refrigeration, Hydronics, and Electrical Contractors.

The registration fees are low, the liability insurance requirements are very reasonable, and there will be a grandfathering period for all existing roofing contractors to apply for the license. You can find the full text here:

This license gives the industry more tools to address the issues of the increasing complexity of roofing systems and the need to ensure code compliance for occupant safety and the safety of our first responders.

It also requires all subcontractors performing roofing system work on the project to be licensed. The currently licensed industries have used the OCILB enforcement provisions for decades to **successfully reduce the misclassification of workers** as subcontractors.
